BOARD OF EDUCATION, THORNTON TOWNSHIP HIGH SCHOOL DISTRICT NO. 205 HELD AT THORNRIDGE HIGH SCHOOL 15000 COTTAGE GROVE AVENUE, DOLTON, ILLINOIS, AND VIA MICROSOFT TEAMS CONFERENCING AT 6:30 PM

Dr. Cunningham stated the following:

SUPERINTENDENT REPORT

Our district vision is to build an exemplary high-quality organization that produces major gains in student achievement and prepares all students to be productive citizens in a global society. Our district mission is to develop productive citizens who are enrolled, enlisted, or employed at the completion of high school. Our core values are empathy, trust, pride, responsiveness, high Expectations with High Support, Integrity, Commitment to Excellence, Innovation, and Collaboration. These things are designed to impact our student's and community's futures. Our goals district goals this year were based on a publication called "What Matters for Staying On-track and Graduating in Chicago Public High Schools: A Close Look at Course Grades, Failures, and Attendance in the Freshman Year" by the University of Chicago, Consortium on Chicago School Research, Chicago, IL, 2007. In this study of the freshman year of high school, researchers found that graduation was significantly impacted by students being on track (having the prerequisite number of credits by semester). The researchers also found that attendance in this pivotal transition year was a key indicator of whether students would finish high school. It also stated that attendance and studying are more predictive of dropout than test scores or other student characteristics. In fact, 9thgrade attendance was a better predictor of dropout than 8th-grade test scores. Our goal for our schools is that 95% of our freshmen are on track for graduation. A prerequisite is that our students be in school to learn and perform academically.

Our district continues to have some major academic successes for our students. We have students from Harvard to Stanford and all points in between. Not all school districts have students attending top universities like Harvard and Stanford, but we do. Not all school districts have students who earn Gates Scholarships, but we do. Our challenge is that we must get a higher percentage of our students to perform at high levels - defined as grade level and above. One of the biggest hurdles in that challenge is getting kids to come to school. Truancy, the intentional, unjustified, unauthorized, or illegal absence from compulsory education in our district, is rampant in our community. The deliberate absence of our students' own free will happens hourly and daily. How does the data say school attendance impacts our graduation rate?

Most school systems use truancy and average daily attendance (ADA) to track student absences. In tracking truancy, schools only count full days of absences; this completely ignores students who miss individual periods or who come to school late

every day. ADA - The total number of student attendance days divided by the total number of days in the regular school year; it underrepresents absences and the about of time students are not at school. A student attending every day would equal one ADA. We have developed a new system based on best practices that include the understanding that we want all of our students to attend school every day. The new system of monitoring attendance is more powerful than truancy or average daily attendance, two previously applied methods. Unlike average daily attendance, which counts how many students show up on a given day, or truancy, which measures unexcused absences only, our system identifies how many students miss at least 15 days for any reason, excused or unexcused. It also identifies students who miss partial days. Let me define some vocabulary for you so we can all be on the same page. Defining Regular Attendance as 1 absence or less a month is regular attendance at less than five percent, defining At-Risk Attendance (5.1% - 9.9%), Chronic Absence (10% – 19.9%), and Severe Chronic Absence (20% or More). We must understand the issues and focus on the settings.

With these new attendance measures in place, chronically absent students are less easily lost in daily attendance snapshots. It will assist the school system in educating parents on our attendance expectations and why we have those expectations. Moving to chronic absenteeism as a measurement is a more specific and useful data point to properly address school attendance and the myriad risk factors of absenteeism.
